**Salcare** provides services 24 hours a day, seven days a week. Consumers and staff can reach a supervisor by phone at all hours.

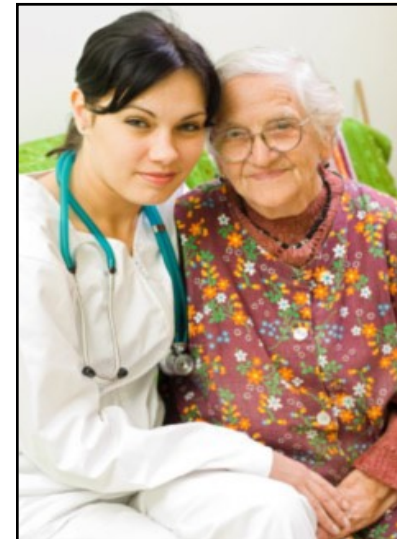
